

Indices of Deprivation Summary 2010 - Colne and District Area



Overview of the 2010 Indices of Deprivation

The Indices of Deprivation is considered the most significant research into poverty in England ever put together and is used to allocate around 1% of all government funding. The regional boundaries it covers are Lower Super Output Areas which usually have a population of around 1,500 people. The data used for this release was mainly taken from 2008 and is based on 38 indicators across 7 domains. These domains are:

- Income Deprivation
- Employment Deprivation
- Education, Skills and Training Deprivation
- Crime
- Health Deprivation and Disability
- Barriers to Housing and Services
- Living Environment Deprivation

Boulsworth Ward

With an estimated population of 5,261 people (ONS 2009), Boulsworth is made up of 3 Lower Super Output Areas (LSOAs):

E01025178 Pendle 006A (1,879 people)

E01025179 Pendle 006B (1,570 people)

E01025180 Pendle 006C (1,812 people)

The average Index of Multiple Deprivation (IMD) score across the country is 21.67. In Boulsworth, the average score was 14.5. Broken down by LSOAs the scores were as follows:

Pendle 006A 12.40
Pendle 006B 18.26
Pendle 006C 12.84

None of the three LSOAs in Boulsworth are in the 10% most deprived LSOAs in the country for any of the seven domains that make up the IMD. However, worth noting is that Pendle 006B is in the top 10% most deprived LSOAs in the country for poor 'indoor' living environments (housing in poor condition and without central heating).

Foulridge Ward

Foulridge has an estimated population of 1,672 people (ONS 2009) and is itself the LSOA E01025203 Pendle 006D.

The average score of multiple deprivation for Foulridge in 2010 was 10.15 which is half the average of all LSOAs in the country. Like Boulsworth deprivation is low in Foulridge and it does not feature in the top 10% LSOAs in the country for any type of deprivation.

Horsfield Ward

Horsfield has an estimated population of 5,158 people (ONS 2009) and is made up of 4 LSOAs:

E01025205 Pendle 004A (1,363 people)
E01025206 Pendle 004B (1,303 people)
E01025207 Pendle 004C (1,161 people)
E01025208 Pendle 004D (1,331 people)

There are varying levels of deprivation in the Horsfield ward based in the 2010 Indices of Deprivation. The average score for Horsfield is 33.6 which is above the national average of 21.67. In terms of deprivation at the LSOA level in Horsfield scores range from a low of 16.88 in Pendle 004B to a high of 48.81 in Pendle 004C. Indeed, Pendle 004C falls into the top 10% most deprived LSOAs in the country.

Looking at parts of Horsfield scoring highly for deprivation at the various domain levels the following statistics are cause for concern in the ward:

- Pendle 004C ranked 395th out of 32,482 LSOAs in England for high crime rates
- Both Pendle 004A and 004C in the top 10% most deprived LSOAs in England for the living environment
- Both Pendle 004C and 004D in the top 10% LSOAs in the country for health deprivation and disability

Vivary Bridge Ward

Vivary Bridge has an estimated population of 5,655 people (ONS 2009) and is broken up into 4 LSOAs:

E01025220 Pendle 005A (1,475 people)
E01025221 Pendle 005B (1,397 people)
E01025222 Pendle 005C (1,473 people)
E01025223 Pendle 005D (1,310 people)

The average score of multiple deprivation in Vivary Bridge in 2010 was 33.64 which is higher than the national average of 21.67. The deprivation scores for the individual LSOAs within Vivary Bridge show that there are varying levels of deprivation in the ward. At the bottom of the scale Pendle 005C has a score of 15.34, compared to Pendle 005A with the highest score in the ward of 51.1.

Pendle 005A is in the 10% most deprived LSOAs in the country. Moreover, it is in the 10% most deprived LSOAs in England for 4 of the 7 domains that make up the IMD. The rankings are (out of 32,482 LSOAs):

- 1953rd for income deprivation
- 2267th for employment deprivation
- 1600th for education, skills and training deprivation
- 1432nd for health deprivation and disability

The most deprived living environment in Vivary Bridge is actually in Pendle 005D with a ranking of 2639th (out of 32,482). In addition, this LSOA is also in the top 10% in the country for health deprivation and disability.

Waterside Ward

Waterside has an estimated population of 5,011 people (ONS 2009) and is made up of 3 LSOAs which are:

E01025226 Pendle 007A (1,484 people)

E01025227 Pendle 007B (1,888 people)

E01025228 Pendle 007C (1,639 people)

The average IMD score for Waterside in 2010 is 45.35 which is more than double the national average of 21.67. Moreover, when we break it down to LSOA level there is quite a difference in the levels of deprivation. Pendle 007C has a deprivation score of 19.48 which is lower than the national average, whereas the score of 61.67 for Pendle 007B is nearly 3 times the national average and makes it the 4th most deprived LSOA in Pendle.

Both Pendle 007A and 007B in Waterside score highly for deprivation in a variety of domains. Both are in the top 10% in the country for overall deprivation and employment deprivation. Moreover, both are in the top 10% for health deprivation and deprived living environments. Indeed, Pendle 007B is ranked 228th out of 32,482 LSOAs in England for living environment deprivation.
