Pendle Core Strategy Examination Hearings

It would be particularly helpful if statements address what specific changes, including the suggested wording, are required to make the Plan sound, unless your original representations did so.

In preparing your statements you might find it particularly useful to look at the Examination Documents on the website which include correspondence between the Inspector and the Council. In addition the Council will shortly be producing Schedules of *Main Modifications* and *Additional Modifications*, some of which will be in response to representations made on the Core Strategy (Pre-Submission Report September 2014 version). As with all other examination material these will be published on the website. The Schedules will be updated during the examination.

Please let me know if you require clarification on the above or any other aspects of the Examination.
