STANDARD OF HACKNEY CARRIAGE AND PRIVATE HIRE VEHICLES

PURPOSE OF REPORT

To examine a number of options in which the standard of licensed vehicles can be improved.

RECOMMENDATION

(1) That the options outlined in the report be considered.

REASON FOR RECOMMENDATION

To improve the standard of licensed vehicles within the Borough.

BACKGROUND

- 1. A list of licensed vehicles failing the Council's taxi test from 1 January to 31 December 2010 was submitted, for information, to the last meeting.
- 2. As the number of vehicles failing the test was high, members asked for a further list from 1 January 2010 to 31 May 2011. This is attached as Appendix 1.
- 3. There are also a high number of vehicles failing evening spot checks which are carried out with the police and the Vehicle and Operator Services Agency (VOSA), especially the last one carried out in March of this year. A list of vehicles that have failed spot checks from 1 January 2010 to 4 March 2011 is attached as Appendix 2.
- 4. All vehicles are tested by one of the Council's appointed garages once a year if they are less than three years old and twice a year for any vehicles older than this.
- 5. The test is more stringent than an MOT test and vehicles have to comply with the Council's vehicle standards.

ISSUE

- 6. Some operators/owners are still using the taxi test as a fault-finding exercise and not carrying out any checks in between tests. This is clearly shown when evening spot checks are carried out with the police and VOSA.
- 7. A number of options are set out below that would target the operators/owners who are not keeping their vehicles up to our standards.

OPTIONS

8. **Option 1**

If a vehicle fails the garage taxi test, spot check or school spot check, the number of tests per year be increased from two to three and they revert to a four-month licence.

9. **Option 2**

At present, if a vehicle fails a taxi test a free re-test is available if it goes back within 48 hours. After the 48 hours, a re-test fee applies. The garages do not charge this and the vehicle can be presented for a re-test many days after the initial test. The re-test fee should be brought back in and the garages instructed to charge the re-test fee as stated in their contract.

10. **Option 3**

The vehicle is taken off the road if it fails on two or more occasions the taxi test, spot check or school spot check with one or more serious faults. Serious faults would be steering and suspension, braking system and tyres/wheels.

11. **Option 4**

That the age limit be reduced, although if vehicles are not being maintained between tests, newer vehicles will not fair any better than older ones.

12. **Option 5**

Any operators/owners whose vehicles consistently fail the taxi test be asked to attend the Taxi Licensing Committee to establish whether they are fit and proper to hold an operator's or vehicle licence.

CONCLUSION

13. The standard of our taxi fleet needs to improve and by bringing in one or a number of the above options this can be achieved.

IMPLICATIONS

Policy: The current age limit for a saloon vehicle is no older than 7 years when first licensed and can continue to be licensed until 9 years of age. For wheelchair accessible vehicles, these must be no older than 10 years when first licensed and can continue to licensed until 15 years if a permanent ramp or lift is fitted.

A taxi test is required when the vehicle is first licensed and then once a year for vehicles less than three years old and twice a year thereafter.

A hackney carriage or private hire vehicle licence is issued for six or 12 months.
