RESULTS OF SPOT CHECK ON 7 DECEMBER 2012

PURPOSE OF REPORT

To report the results of a spot check carried out on 7 December 2013.

RECOMMENDATIONS

- (1) That the report be noted.
- (2) That members note that details of firms whose vehicles fail spot checks are already made available in this and similar reports to this Committee.
- (3) That members consider the request at the last Full Council meeting for more spot checks to be carried out.

REASON FOR RECOMMENDATIONS

To improve the standard of licensed vehicles within the Borough.

ISSUE

- 1. A joint spot check on licensed vehicles was carried out on the evening of Friday, 7 December 2012, at Norfolk Street Garage with the police and Vehicle Operator Services Agency (VOSA). Eighteen vehicles were tested in total, with 11 of those being taken off the road. A list of the vehicles tested and faults is appended to this report. The vehicles which failed the spot check will now revert to a four-month licence and test.
- 2. At the last meeting of the Full Council on 18 December 2012, a request was made for consideration to be given into publishing the names of vehicle owners whose vehicles failed spot checks and for more spot checks to be carried out.

3. The relevant minute reads:

"Councillor TA Cooney asked if the Leader could comment on the poor pass rate of Pendle taxis during spot checks carried out by Pendle Taxi Licensing officers over the last two years and whether the number of spot checks should be increased in the interests of public safety?

The Leader said that the pass rate at spot checks of Pendle's taxis was disappointing, although he believed that it was only a small number of taxi operators that needed to make serious improvements. The number of annual spot checks and the penalty point system was a matter for the Taxi Licensing Committee to consider.

In answer to a supplementary question from Councillor LM Crossley, the Leader said that he would discuss with the Engineering and Special Projects Manager the possibility of publishing details of the small number of taxi operators who had a bad record so that residents of Pendle were aware of them."

4. This current report is in a format which we regularly submit to Committee. Councillors will see that the report is not confidential and that the attached list of failures contains details of company names, vehicle registrations and faults. These details are therefore already available for publication.

Policy: Tests are carried out once a year for vehicles less than three years old and twice a year for vehicles over three years old. For vehicles failing on serious faults, tests are carried out three times a year.
