2. MINUTES OF LAST MEETING

The minutes of the last meeting held on 26th January were approved as a correct record.

3. MATTERS ARISING

Fairtrade Fortnight: 23rd February – 8th March

All resources were received from the Fairtrade Foundation. £20 in vouchers had also been donated from the Co-op Group and these, together with £10 which Sheila donated from her ward initiative funding, was used to buy Fairtrade items for a stall outside Nelson Market Hall on 27th February. Sheila reported that there had been a lot of interest in the stall and all the Fairtrade items had been given away.

A Fairtrade display was put up in the glass house outside Colne Market Hall during the second week.

A range of posters had also been put on display in Nelson Town Hall, Number One Market Street and Elliott House.

Pendle Pupil Parliament

At the last meeting it was reported that the Pendle Pupil Parliament had asked if a representative from the Pendle Fairtrade Group could attend their meeting on 6th February to highlight Fairtrade in Pendle.

Sheila attended the meeting, along with Susan and Audrey. The children were very interested in Fairtrade football and were presented with some Fairtrade Footballs by Colne football Club, organised by Councillor Jennifer Purcell. It is hoped that the children will organise a Fairtrade Football Tournament in the near future.

Fairtrade Status

Tim reported that Lancashire got the green light on the 27th February to make Lancashire a Fairtrade County. There had been some good publicity surrounding this with articles in the Lancashire Evening Post and Telegraph.
