






A MEETING OF THE

2. SCRUTINY REVIEW OF DISTRICT NURSE PROVISION

3. SCRUTINY REVIEWS

(a) Adult Social Care – Recommissioning of Homecare Services

Enc. At the last meeting of the Panel, Members agreed to continue reviewing aspects of social care, with particular focus being placed on the re-organisation taking place at Lancashire County Council (LCC) and the proposed reduction in the number of accredited agencies in Pendle.

(b) Eye Care Provision
