Open a new strategic site in the M65 growth corridor by extending Lomeshaye Industrial Estate Our Core Strategy identifies the extension of Lomeshaye as a strategic employment site with a gross area of 30.59ha which could accommodate over 1500 jobs. The Examination Hearing Sessions for the Core Strategy concluded on Tuesday 28th April 2015. We now await the inspector's report which is due on the 23 October 2015. Help to develop Northlight in line with the masterplan We've secured development partners for housing, hotel and leisure uses and a complex funding package has been put in place to help secure further development.	 Once the Core Strategy has been adopted, site investigations will be carried out before we submit a planning application for the site. In the meantime we are encouraging private investment on a number of employment sites in Pendle, including: filling the remaining plots at Barrowford Business Park redeveloping the former Reedyford Mill site, Nelson creation of a garden centre at Greenfield, Colne Now the funding package has been secured, We will progress the acquisition of some adjoining pieces of land which will be needed to deliver the proposed redevelopment of the mill complex. We will continue to work with development partners to ensure the elements of

Strengthen commercial activity in our town centres Our purchase of the former Colne Health Centre is progressing. A working group has been formed to oversee the development of this site and other key sites in the area. The Nelson Portas Pilot is almost completed. Vacancy rates have been reduced faster in Nelson than in the rest of England. The last commission by the Town Team was the Nelson Food Festival which was held in September 2015 and was a great success. Estimates of 6000-8000 thousand people flocked to the town and over half of the businesses surveyed post event reported an upturn in trade on the event day.	We will continue to develop a regeneration strategy for Colne, Nelson and Brierfield to ensure future investment is targeted effectively.

In 2013-15 we invested £488,649 into the Gearing Up For Growth programme to support and strengthen the local economy, resulting in around £1.8m of private sector investment. Lobby for LCC to deliver the Colne Foulridge Bypass		
The M65 Yorkshire Corridor study was commission by Lancashire County Council to investigate whether a bypass remains an appropriate solution to Colne's current congestion. The results were published as part of the East Lancashire Highways Transport Masterplan. The report concluded that further detailed traffic modelling is required to identify and take forward proposals. The report explained that it is not possible at this stage to categorically state that any one specific corridor should be the primary focus. The report proposes further work to continue to identify options to relieve congestion in and around Colne, including whether the case continues for a bypass of Colne to the Northwest of the town to link the M65 and A56.	We will continue to lobby and make a strong economic case for funding the Colne Foulridge bypass.	

Lobby LCC to deliver the Route Management Strategy for North Valley corridor Junction 14 to A56/A6068		
We have successfully lobbied for investigations in to route management in north valley. Funding has been secured to carry out upgrades to signals on the North Valley corridor and a further report to investigate the issue is currently underway. We participated in the Burnley/Pendle Growth Corridor Study and the East Lancashire Accessibility Study to look at what needs to be done to make sure our roads can support planned economic growth. LCC started improvements to junction 12 and 13 of the M65 and adjacent roads in August 2015 as part of the Burnley Pendle Growth Corridor Investment Programme. This is part of the £250m Growth Deal secured from government by the Lancashire Enterprise Partnership.	Completion of work is expected before summer in 2016.

We have carried out survey work to determine the best layout for our site at Further Clough Head, Nelson Pearl developed eight houses for Together Housing on Phase 1 of the Bunkers Hill site at Colne. Through the Empty Homes Programme we've awarded loans to bring houses back into use and we've completed a range of high quality public realm and streetscape work in Brierfield and Bradley.
