PUBLIC SPACES PROTECTION ORDERS FOR CEMETERIES, PLAY AREAS AND MULTI-USE GAMES AREAS

PURPOSE OF REPORT

To update the Executive on proposals and options for Public Spaces Protection Orders (PSPOs) in relation to cemeteries, play areas and multi-use games areas (MUGAs) in Pendle.

RECOMMENDATIONS

- (1) That the report and commencement of the consultation process be noted.
- (2) That regular reports be submitted to the Executive to enable it to monitor progress.

REASON FOR RECOMMENDATIONS

To enable the Council and its partners to respond to concerns regarding dogs in play areas and MUGAs including enforcement action.

ISSUE

1. At the 23 July 2015 meeting of the Executive a report was submitted on Public Space Protection Orders and Dogs.

The report included:

- the legal background (the Antisocial Behaviour, Crime and Policing Act 2014);
- the Conduct Test to be applied before implementing a Public Space Protection Order;
- the statutory consultation process (see below).
- 2. It was resolved:
 - (1) That the plan and timetable, as set out in the report, be agreed.

- (2) That a report detailing cost implications for the erection of signs, etc be submitted to a future meeting and that regular reports be submitted to the Executive to enable it to monitor progress.
- (3) That a report be sent to the Area Committees in relation to the conversion of the Borough-wide dog fouling orders to PSPOs and to consider making PSPOs banning dogs from play areas and MUGAs outside parks to the September round of meetings.
- 3. Following the round of reports to Area Committees in September (responses in the Appendix to this report), it has been identified that one or more PSPOs are required to:
 - replace the Borough-wide order requiring people in control of dogs to pick up and remove dog fouling in public places forthwith;
 - replace the dog control orders for cemeteries within the Borough requiring people in control of dogs to have the dogs on a lead at all times. Some of these orders limit the number of dogs allowed per person;
 - replace the dog banning order on the Remembrance Garden in Barrowford Park; and
 - ban dogs and smoking within the 31 play areas and 15 multi-use games areas located outside of parks.
- 4. The proposal for play areas and MUGAs outside the 11 formal parks currently under consideration for possible transfer to town and parish councils is with a view to the PSPOs being in place ahead of any agreed transfer as the town and parish councils will not have the authority to introduce PSPOs themselves.
- 5. The public consultation carried out by the Dogs Working Group highlighted the continuing very high level of concern about dog fouling. There was also a high level of concern about the lack of restrictions on dogs in children's play areas and multi-use games areas along with sports areas and parks generally.
- 6. There is also concern that smoking in areas designated for exercise and play is not compatible with the Council's role in promoting health and wellbeing and the Council's no smoking policy. Including no smoking in the PSPO is consistent with the no smoking signage already in place on all play areas and MUGAs.
- 7. The intention is to consult on a single, Borough-wide PSPO that would:
 - replicate the wording in the current Dog Control Orders;
 - prevent people in control of dogs from taking them into or allowing them to enter any of the 31 play areas or 15 MUGAs identified in the PSPO;
 - prevent anyone using, visiting or accompanying a child or young person who is using or visiting any one of the 31 play areas or 15 MUGAs identified in the PSPO smoking at any time whatsoever including the use of electronic cigarettes.
- 8. Consultation is a requirement of the legislation. Although the requirement is around the Council's statutory partners and appropriate community representatives, best practice from around the country shows an increasing tendency towards public consultation through the press, social media and online surveys.
- 9. The proposed consultation plan for this PSPO involves:
 - consultation with statutory partners and community representatives, in particular the town and parish councils, around the final draft wording of the full PSPO;

- press and social media publicity around the inclusion of the current dog control orders in a PSPO and inviting comments to a single point of contact within the Neighbourhood Services Team; and
- press and social media publicity around the proposals for the play areas and MUGAs inviting the public to participate in an online survey on the proposals.
- 10. The consultation process has begun. The outcome of the consultation together with a final draft PSPO will be reported to the Executive in January and the Area Committees in February for them to authorise the making of the necessary Orders.
- 11. The statutory requirement for publicising a PSPO once agreed is appropriate signage at the sites to be included and advice on the Council's website. Estimates have been obtained for the signage required to implement this PSPO at a cost of approximately £6,000.
- 12. On 28 May 2015 the Executive considered a report from the Dogs Working Group. It was resolved, inter alia:
 - "(2) That the Keep Britain Tidy's 'We're Watching You' campaign be adopted in selected parks, play areas and cemeteries throughout the Borough.
 - (3) That the Neighbourhood Services Manager be asked to produce information for residents and visitors to the Borough advising them of the Council's and other agencies' responsibility in relation to dog issues."
- 13. A fund of £1,500 has been put aside for the "We're Watching You" campaign and officers are highlighting potential hotspot areas where the signage can be used. The application to Keep Britain Tidy is due to be made soon with a view to implementation alongside the PSPO signage from April 2016.
- 14. The information for residents and visitors has been produced, printed and is ready for distribution to all Council offices and will be available in all libraries, veterinary practices, pet shops and community halls and will be publicised through a press release.

IMPLICATIONS

Policy: The legislation reinforces the continuing role of the Council in relation to the control of dogs throughout the Borough and responding to any antisocial behaviour related to dogs through the actions of the Environmental Crime and Community Protection Teams.

Financial: The opportunity the legislation provides and public expectation imply that these powers will be used by the Council and cost will be incurred. It is anticipated that the implementation and the enforcement of the powers described above can be dealt with within existing staffing resources.

The cost of publicising the Orders (ie signage at all entrances of an area covered by an order per entrance) is estimated to be £6,000. This will be met from existing revenue budgets.

Legal: The Council has the lead role on the use of PSPOs. Members of the public have a right of appeal on the basis the Council did not have the power to make the order or to include particular prohibitions or requirements or that one or more of the preliminaries has not been complied with (eg consultation). Appeals are heard in the High Court.

Risk Management: The legislation supports those elements of the Risk Management Plan relating to community safety; environmental crime and environmental protection.

Health and Safety: Direct intervention in the enforcement of breaches poses a risk for the staff involved which is mitigated through the Council's risk assessments, lone working policy, use of the Volcano database and working in partnership with other agencies.

Sustainability: The legislation supports those elements of the Sustainable Communities Strategy relating to community safety; environmental crime and environmental protection.

Community Safety: The legislation re-enforces the continuing role of the Community Safety Partnership; the Partnership Plan and local delivery on community safety within an area and county based strategic landscape.

Equality and Diversity: The legislation was subject to a detailed government impact assessment.
