Responses are still awaited from Lead Local Flood Authority and LCC Highways to further information provided in order to address the drainage and highway issues outstanding.

A Bat Survey has been submitted which states that further surveys will need to be carried out prior to development commencing this is controlled by condition 12.

With regard to the proposed demolition of the buildings further information has been provided in accordance with National Planning Policy Framework para 132 this information does not change the position that this justification is marginal as any harm to the heritage asset requires a clear and convincing justification.

However, whilst there would be harm to the heritage asset which is the conservation area this would be less than substantial which should be weighed against the public benefit which would arise from this scheme which in this case include the economic benefit of bringing this vacant listed mill complex back into appropriate use and create job opportunities as well as the social benefits from the to the wider area and the environmental benefit from preventing the fabric of the mill complex falling further into disrepair and neglect.

On this basis the proposal to demolish would be favourable.

It is therefore recommended that Members Delegate the decision to the Planning, Building Control and Licensing Manager to issue a decision notice upon receipt of acceptable responses from LCC Highways and Lead Local Flood Authority being received subject to any further appropriate conditions.
