# CAPITAL PROGRAMME 2015/16 AND 2016/17

The Neighbourhood Services Manager gave an update at the meeting that in light of the Executives resolution on 30<sup>th</sup> June, 2016 to return the funds held back from 2015/16 as well as the amended resolution to allocate £600 for litter and dogs waste bins, the current balance for the Committees Capital Programme for 2016/17 was £12,989.

In addition, it was reported that the payment had been made for the purchase of the commercial oven at Trawden Forest Community Centre for £525.13, which was much less than originally envisaged, resulting in an underspend of £975.

Member were asked to de-allocate these funds and return them to the Capital programme.

The Committee considered a bid from Pendle's Cycle Forum for £1,000 towards Pendle's Cycling Legacy Event.

# RESOLVED

- (1) That the underspend of £975 from the purchase of the commercial oven be re-allocated to the Boulsworth Environmental Improvement/ Horticultural fund.
- (2) That £6,500 be allocated to the Environmental Improvement/Horticultural fund (£500 per councillor to be spent within their ward)

- (3) That no funding be allocated towards Pendle's Cycle Forum event.
- (4) That it be noted that the following allocation of funding for horticulture projects/events be transferred as follows:-

# (a) Shop on Glen Street, Colne

Councillor Cooney made reference to the state of both the front and rear of the shop on Glen Street, Colne and asked if Officers could investigate it and take action to get it tided up.

Councillor Cooney reported that the Parks Department had agreed to reinstate the hedge that they had removed to try reduce anti-social behaviour. It was reported that the hedge had been cut so far down that the existing roots would need to be taken out before a new hedge could be replanted. Councillor Greaves reported that he had written to the Corporate Director asking for an explanation as to why Councillors and the Friends group were not formally consulted before the hedge was cut down.

# PROBLEM BUILDINGS

The Planning, Building Control and Licensing Services Manager submitted an update on problem buildings in the area.

It was reported that the owner of the former Hycrome works had discussed wanting to move the scheme forward by demolishing the factory and turning the office block into apartments.

# Colne and District Committee (07.07.2016)

A short discussion took place regarding the Tower Ballroom which was currently for sale. It was reported that the Council owned the building next to it and it would be an ideal opportunity for PEARL to acquire the ballroom with a view to turning both buildings into apartments.

Reference was made to the condition of the property at 95 Skipton Road, some of the windows had been boarded up and the inside of the property was also in a poor state. There had been numerous complaints from residents in the area as the property was causing antisocial behaviour due to its state.

- (4) That the Community Protection and Localities Team be requested to serve a Community Protection Order on 95 Skipton Road, Colne.
