Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the Premises Licence at a time when there is no Designated Premises Supervisor in respect of the Premises Licence or at a time when the Designated Premises Supervisor does not hold a Personal Licence or his/her licence is suspended.

Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.

The following condition came into force on 1st October 2010, amended 1st October 2014

A3.

(1)

The Premises Licence holder or Club Premises Certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The Designated Premises Supervisor in relation to the Premises Licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

(a)

a holographic mark, or

an ultraviolet feature.

The following condition came into force on 28th May 2014

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purpose of the condition set out in paragraph 1 -

duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979 [1];

'permitted price' is the price found by applying the formula P = D + (DxV), where

P - is the permitted price

D - is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

V - is the rate of Value Added Tax chargeable in relation to the alcohol as if the Value Added Tax were charged on the date of the sale or supply of the alcohol;

'relevant person' means, in relation to premises in respect of which there is in force a Premises Licence -

the holder of the Premises Licence

the Designated Premises Supervisor (if any) in respect of such a Licence, or

the Personal Licence holder who makes or authorises a supply of alcohol under such a Licence;

'relevant person' means, in relation to premises in respect of which there is in force a Club Premises Certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

'Value Added Tax' means Value Added Tax charged in accordance with the Value Added Tax Act 1994 [2].

Where the permitted price given by paragraph(b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- [1] Sub-paragraph 2 applies where the permitted price given by paragraph (b) of paragraph 2 on a day ('the first day') would be different from the permitted price on the next day ('the second day') as a result of a change to the rate of duty or Value Added Tax.
- [2] The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the Operating Schedule

B1. Prevention of Crime and Disorder

B1.1

A CCTV system will operate at the premises, covering both inside and outside the premises. The system will be maintained in proper working order.

B1.2

The system will be operated during all hours the premises are open to the public.

B1.3

Recordings will be held for a minimum of 14 days.

B2. Public Safety

B2.1

Staff will be trained to be vigilant at all times and to take appropriate action if there are any instances of disorderly behaviour at the premises.

B3. Prevention of Public Nuisance

B3.1

Management and staff at the premises will make every effort to prevent groups of people, particularly youths, from congregrating outside the premises and causing a nuisance.

B4. Protection of Children from Harm

B4.1

Any person who looks or appears to be under the age of 21 will be asked to provide one of the following forms of identification to prove that they are over 18 years of age:

UK photo driving licence

Passpor

PASS Card (Proof of Age Standards Scheme)

Anyone unable to prove their age will be refused service.

B4.2

Challenge 21 posters will be displayed at the premises.
