The meeting will commence with PUBLIC **QUESTION TIME.** Members of the public are invited to attend and ask questions of the Committee.


Members of the public may also speak on any agenda item in which they have a direct interest. Petitions may also be presented.

- 11. Treatment of Himalayan Balsam

At the last meeting it was noted that various volunteer groups were helping to eradicate Himalayan Balsam. The Committee asked for an update on what the Council was doing to tackle this invasive weed.

The Neighbourhood Services Manager reports that Himalayan balsam is a non-native species that is found especially on riverbanks and on waste ground (but can also invade gardens) where it has become a problem weed. The pink flower grows rapidly (it can grow

to between 6-10ft in height) and spreads quickly, smothering native plants and other vegetation as it goes leaving banks bare and subject to erosion when it dies down.

Unlike Japanese Knotweed, there is no strategic treatment/plan in place for tackling Himalayan balsam at the present time by the Council. The amount of balsam in Pendle is significant (perception is that it is more prevalent in volume than JK) and to tackle the invasive weed properly would be an onerous task not only on Pendle Council managed sites but on other private land.

We currently deal with balsam via occasional 'balsam bashing' working days or volunteer events where Council staff alongside volunteers pull the balsam out from its root before they flower and seed. This is usually done between May and October as during the summer the balsam produces clusters of purplish pink helmet shaped flowers. The flowers are followed by seed pods that open explosively when ripe. The balsam must be tackled prior to the seed pods spreading. The uprooted balsam is then disposed of in a green bin where it is left to rot. Once it has decomposed, the mulch can be re-used on green space sites.

#### 12. Land adjacent to Pendleside, Lomeshaye
