CAPITAL PROGRAMME 2016/17 AND 2017/18

PURPOSE OF REPORT

To update members on the Committee's 2016/17 and 2017/18 capital budgets.

RECOMMENDATIONS

- (1) That members note that only the schemes listed in Appendices 1 and 2 have agreed funding.
- (2) That members consider the new bid in paragraph 13 and the comments in paragraph 14.

REASON FOR RECOMMENDATIONS

To enable the capital programme to be allocated efficiently and effectively.

ISSUE

Uncommitted Balance from 2015/16

1. This is £706.

Allocation for 2016/17

2. This is £30,290 capital plus £21,210 revenue contribution to capital – totalling £51,500. However, the £12,120 of the revenue contribution that was held back as cover in the event that savings did not materialise from the transfer of some assets to the town and parish councils from the 2015/16 budget has now been released following the 30 June 2016 Executive meeting. This gives an effective total allocation for 2016/17 of £63,620.

Effective Total Allocation for 2016/17

3. This is £64,326 (made up of £706 plus £51,500 plus £12,120).

Commitments for 2016/17

4. These total £58,578 (see Appendix 1 for a detailed breakdown).

Balance for 2016/17

5. This is £5,748.

New Allocation for 2017/18

6. This is the same as last year, ie £51,500 (comprised of £30,290 capital and £21,210 revenue).

Effective Total Allocation for 2017/18

7. This is £57,249 (made up of £5,749 – rounded up by £1 from last year – plus £51,500).

Commitments for 2017/18

8. These total £37,750 (see Appendix 2 for a detailed breakdown).

Balance for 2017/18

9. This is £19,499.

Additional Sources of Capital Funding

- 10. Appendix 2 to this report is a list (for information) of current Section 106 (Planning) Agreements where finance has been received provided by Planning and Legal Services relating to the Nelson Committee area.
- 11. The Pendle Three-Tier Forum (now disbanded) stressed at its meeting on 1 April 2014 the need to seek match funding for highway schemes and improvements. It was agreed that the Borough Council via its area committees should approach the County Council for match funding wherever possible.

Financial Advice

12. Please refer to the Financial Implications section of this report. Bids for new funding should be submitted on the usual forms (Form A for Internal, Form B for External and Form C for Nelson Ward Initiatives) in order that members can evaluate them on a consistent basis.

New/Deferred Bids

13. *Alleygating Maintenance: £3,025.* Bid submitted by Geoff Whitehead, Community Protection and Localities Team (see bid form A in Appendix 4).

Existing Bids

14. Can the members please note the de-allocation of item 6 in Appendix 2 of £5,540 for "Locality working in the Southfield ward" funds had been earmarked for the improvements to the Athol Street triangle following the acquisition of the site (item 8) and therefore these funds will still be required.

IMPLICATIONS

Policy: The capital programme is required to be allocated and managed in accordance with the Council's Corporate Capital Strategy 2015/18.

Financial: Expenditure for capital purposes is primarily expenditure on the acquisition, reclamation or enhancement of assets (eg buildings, land, plant and machinery). "Enhancement" means substantially lengthening the useful life of the asset, substantially increasing its open market value or substantially increasing the use of the asset. Other expenditure for capital purposes can include computer costs (for use over a period exceeding one year) and incidental costs involved in a capital project (eg officers' salaries and professional fees). Anything not covered by "proper practices" must be treated as revenue expenditure.

As in previous years, and in accordance with proper accounting practice, the revenue allocations can be used to fund capital expenditure but under no circumstances can the capital allocation be used to fund revenue expenditure.

A list of good practice in the allocation of funding has been proposed by the Council's Chief Finance Officer in order to assist members when considering the allocation of the capital and revenue budgets. The list is as follows:

- 1. The funding should assist a scheme which contributes to meeting the Council's corporate priorities.
- 2. Allocate reasonable amounts to projects early to allow for effective planning and implementation.
- 3. Look for opportunities to maximise the effectiveness of the allocation through match funding.
- 4. Consider allowing some contingency for projects that may be presented during the year.
- 5. Try to avoid allocation of funds at the end of the financial year.
- 6. Consider the revenue consequences of capital schemes in terms of ongoing cost.

Legal: There are legal implications for a number of the proposals listed above in terms of necessary permissions, agreements and possible long-term liabilities and responsibilities.

Risk Management: The capital programme is required to be allocated and managed in accordance with the Council's policies and procedures. The proper management of the programme is intended to minimise any exposure to unnecessary risk associated with the programme and the individual schemes within it.

Health and Safety: The implementation of the programme has associated risks in terms of health and safety. The Council is required to meet all relevant legal requirements for the effective management of health and safety risk and has policies and procedures in place to ensure health and safety standards are maintained.

Climate Change: Some of the schemes identified will encourage the reduction of carbon emissions, such as traffic calming schemes and cycle facility provision.

Community Safety: A number of the schemes listed above have implications in terms of community safety. Wherever possible, the projects are managed in a way that enhances community safety.

Equality and Diversity: The capital programme is required to be allocated and managed in accordance with the Council's policies and procedures, including those relating to equality and diversity.

Brief details of Project: Under the Public Space Protection Order (PSPO), the Neighbourhood Services Manager submitted a report regarding a statutory consultation on proposals to maintain the closure of footways by alleygates scheme. On 9 January 2017, Nelson Committee resolved that a PSPO for the existing schemes be agreed. There are seven alleygate schemes in Nelson comprising of 17 gates; all the schemes require repair and complete paintwork costing £3,025. The schemes are located at:

- Every Street
- Every Street/Hargreaves Street
- Garden Street
- Bradshaw Street
- Bentley Street
- Beaufort Street/Leamington Street/Meredith Street
- Elizabeth Street/Fleet Street/Rook Street
