#### HIGHWAYS MATTERS

9. <u>Proposed Traffic Calming on Greenfield Road, Colne</u>

The Neighbourhood Services Manager reports that residents on Greenfield Road, Colne have been consulted on three options for traffic calming measures. Of the 20 households consulted 14 responses were received:

		Preferred Option
Option 1	Rebuild existing humps to Whitewalls Drive	0
Option 2	Rebuild existing humps and add 3 new sleeping policeman style humps to Colne Road	6

5 of the residents nearest to Whitewalls Drive agree to a gate. 5 of the 13 residents in the middle section of Greenfield Road don't want a gate; 4 do want a gate and 4 didn't respond.

The Environmental Services Manager has indicated that the humps would not cause a problem for the refuse vehicles but the installation of a gate may be restrictive for the vehicles. From comments received from residents it has been suggested that a lockable gate be installed and locked until the majority of people who use Greenfield Road as a rat run get tired of that route. The gate could then be left open and locked again should the problem reoccur.

Funding is in place for the road humps but not for the proposed gate.

#### RECOMMENDATION

That Option 3, to rebuild the existing humps, add 3 new sleeping policeman style humps to Colne Road and the installation of a lockable gate (to be locked temporarily until the problem with people using Greenfield Road as a rat run has ceased) be agreed.
