

The notice of application appearing in the local newspaper was brought to my attention. As the owner of the adjacent domestic property, 8 Skipton Road, I would like to make a formal objection to this application based on the following grounds and concerns:

- noise pollution from food and drink deliveries
- noise pollution from the removal of food waste and empty bottles etc.
- risk of vermin infestation arising from waste and rubbish stored outside and inside the premises
- noise from customers arriving and leaving the premises
- noise transmission from customers through the shared solid party wall between No. 10 and No. 8 Skipton Road
- noise from proposed live music
- light pollution to the front and rear of the premises
- potential parking problems caused by deliveries and collections from the premises
- there is no parking provision for customers parking is restricted at the front on Skipton Road to short stay
- I have a Right of Way across the unadopted road at the rear of the premises to my garage at the head of the cul de sac and require 24/7 access which could be impeded by activities related to the proposed licensed premises as outlined above
- concerns over access for emergency services vehicles
- the proposed development is inappropriate in a residential area and would make life difficult and possibly unsafe for a family and children living at No. 8
- less than 100 metres away, the Station former public house on the corner between the Yorkshire Bank and the Conservative Club is a recently failed business which closed as a pub and is now trading as a bric a brac / home accessories shop called Decisions
- the former Jesters restaurant will shortly open as a micro pub in the town centre
- there are several other pubs in close proximity to 10 Skipton Road which adequately serve the needs of the surrounding population and wider catchment area
- I cannot conceive that a sound business plan has been developed to support the proposed PH and a future failed business at No. 10 would be detrimental to the area and have a potentially negative affect on house prices
- the property is in the Barnoldswick Conservation Area and a change of use from domestic residential to a PH would not be either advantageous or desirable to the residents in the local area or Barnoldswick town centre
- an establishment open from 10.00 until 00.00 could easily attract an undesirable clientele which would be unacceptable to the surrounding houses and detract from the peaceful enjoyment of all other residents and visitors to the town centre
- additional policing resources may be required with the associated additional costs on already stretched manpower and financial resources
