11. DECLARATION OF INTERESTS

Members were reminded of the requirements of the Member Code of Conduct concerning the Declaration of Interests.

12. PUBLIC QUESTION TIME

1. Mr Oakes complained that the Hackney Carriage Association had put forward a number of requests that they wanted the Council to look for example Hackney Carriage ranks within the Borough and there had been no response. He explained that the requests were not unreasonable, but felt that the Council did not want to work with the Association on matters they raised and he felt it necessary to enlist a Barrister to take on his role.

The Chairman asked that the Taxi Licensing Manager arrange with Mr Oakes and the Planning, Building Control and Licensing Services Manager a site visit to look at the ranks within the Borough.

2. Mr Hussain complained about the Blues Festival that ran over the August Bank holiday weekend in Colne and that taxi's from Clitheroe and Burnley were plying for hire and so were a number of private hire vehicles. He explained that the trade were not happy that Albert Road was closed as it caused a lot of issues.

Councillor Cooney explained that the organisation of the Blue Festival was not a Council function as it had been taken over by Colne Town Council and that it had been a huge success. The road closure had been put in place to protect the large amount of public that were on Albert Road. Councillor Cooney reported that there had been a number of breaches of the closure by taxis and they had been reported to the Taxi Licensing Department. He explained that prior to next year's

Blues Festival Colne Town Council would meet with the trade to discuss road closures, pick up points etc.

3. Mr Hussain asked if a meeting of the Working Group could be arranged as the last one was in June 2017. He felt that working group meetings should take place on a regular basis

The Chairman said that a meeting of the Working Group would be arranged before the end of September 2017.

4. Reference was made to new Private Hire businesses setting up and charging a minimum fare of £1.50. Mr Ahmed said that the Council should set the minimum fare as other councils have.

The chairman explained that the Council could only set the minimum fare for hackney carriages but he would put the item on the Working Group agenda for discussion.
