\* In the case of premises in Band D or Band E, where the use of the premises is exclusively or primarily for the carrying on the premises of the supply of alcohol for consumption on the premises, the fee payable will be as follows:

- Band D two times the amount of the fee applicable for that Band
- Band E three times the amount of the fee applicable for that Band

No fee is payable in the case of an application for a Premises Licence which relates *only* to the provision of regulated entertainment made:

- by the proprietor of an educational institution in respect of premises that are or form part of an educational institution – that the educational institution is a school or college and that the provision of regulated entertainment on the premises is carried on by the educational institution for and on behalf of the purposes of the educational institution.
- by Church Halls, Chapel Halls or other premises of a similar nature, Village Halls, Parish and Community Halls or other premises of a similar nature.

Where premises **DO NOT** have a rateable value specified in the local non-domestic rating list, the premises shall be in Band A.
