INTRODUCTORY INFORMATION

1 BURIAL FEES

The fees and charges listed are those applicable to all burials including the Bespoke Ashes section at Colne Cemetery.

2 MEMORIAL WALLS

The fees for the memorial walls include the provision of a plaque and the interment of cremated remains except Salterforth, which includes the provision of an inscription only.

3 GENERAL

All burial fees are inclusive of the digging of the grave, assistance with lowering of the coffin and all reinstatement works after the interment.

4 FOETAL REMAINS

Foetal remains are defined as a foetus that is between 0 and 23 weeks.

5 VAULTS AND WALLED GRAVES

Construction fees for vaults, timber graves and walled graves do not include the interment fee or the fee for the grant of right of burial.

A minimum of 4 working days notice must be received for a vault and 3 days for a walled grave, unless these are pre-prepared.

6 CHAPEL OF REST

Where the chapel is used for the storage or laying out of a deceased person, followed by a burial service or cremation at locations other than Pendle Borough Councils' Cemeteries, the fee in the scale of charges shall be doubled.

7 CREMATED REMAINS

Cremated remains for interment in graves must all be contained within bio-degradable caskets. **No cremated remains will be interred in any other container.**

8 GARDEN OF REMEMBRANCE (Colne Only)

Cremated Remains are poured/scattered on flower garden area.

9 NON RESIDENT FEES

Non-resident fees will apply on the Exclusive rights of Burial and Interment fee where the applicant for the burial (new grant of rights of burial only). Or the deceased are a non-resident of Pendle, for a period greater than 1 year. Also the permit applicant Should the applicant be a non –resident this will be subject to non

Resident fees.
