### 11. DECLARATION OF INTEREST

Members were reminded of the requirements of the Member Code of Conduct concerning the Declaration of Interests.

# 12. PUBLIC QUESTION TIME

(1) Mr. Khan expressed concerns regarding the appointment system that was currently in place for testing vehicles. He felt that it was not working correctly and he was finding it difficult to book his vehicles in, between 9am and 5pm Mon – Fri, when they where on the ranks. Mr. Saeed asked if more tests could be done at the garages at weekends.

The Taxi Licensing Manager explained that it was decided to go back to the appointment system as it was easier to keep a track of the vehicles that were being tested. Reminders go out 4/6 weeks before the test is due, so there was ample time for the vehicles to be booked in. The Taxi Enforcement Officers explained that system had only been in place 2 weeks and they had not received any complaints from drivers.

The Chairman agreed that the system be reviewed in 3 months and be included on the agenda of the next Consultative meeting on 24<sup>th</sup> November 2011 for discussion.

Mr. Saeed also requested that VOSA MOT tests be included on the agenda of the Consultative meeting and 4 monthly tests for vehicles that have failed the test with a major fault.

The chairman agreed that both items would be included on the agenda for the next meeting.

# **RESOLVED**

That the Minutes of the proceedings of this Committee at meetings held on 16<sup>th</sup> June and 17<sup>th</sup> August, 2011 be approved as a correct record and signed by the Chairman.

### 14. PENALTY POINT SCHEME

The Engineering and Special Projects Manager submitted a report regarding the effectiveness of the penalty point scheme.

#### **RESOLVED**

- (1) That the penalty point scheme remains.
- (2) That no penalty points be given for vehicles failing the Council's spot checks.

### REASON

To enable the Taxi Licensing office to deal effectively with minor infringements by the licensing trade, and because vehicles failing spot checks will be dealt with by increasing the number of tests required each year.

### 17. LOCAL GOVERNMENT ACT, 1972

Taxi Licensing Committee (21.09.2011)

In accordance with the provisions of Section 100 (B)(4) of the Local Government Act, 1972, as amended, the Chairman agreed that the following item should be considered as a matter of urgency as the testing of vehicles was not being carried out to the standards laid down by the Council and there was a conflict of interests as the vehicle examiner was driving for a Pendle taxi company.

### 18. AUTOPOINT GARAGE

The Engineering and Special Projects Manager reported that vehicles which were being taken to Autopoint UK, Garden Street, Nelson were not being tested correctly to the Council standards and that the vehicles examiner was driving for a Pendle taxi company.

## **RESOLVED**

That Autopoint UK be given 3 months notice of termination of their taxi testing contract.

### REASON

The testing of vehicles is not being carried out to the standards laid down by the Council and there is a conflict of interests as the vehicle examiner is driving for a Pendle taxi company.
