30. DECLARATION OF INTERESTS

Carriage Licence

Members were reminded of the requirements of the Member Code of Conduct concerning the Declaration of Interests.

31. PUBLIC QUESTION TIME

Mr Ilyas asked what the Council had done to help taxi drivers in Pendle, particularly Nelson, in the last 20-25 years. He was concerned that planning applications for clubs and bars were not being granted which impacted on the taxi trade.

Councillor Cooney pointed out a number of recent measures Colne and District Committee had taken to help the taxi business in Colne, for instance giving up car parking spaces for local taxi drivers and reallocating a taxi rank. Councillor Iqbal pointed out that Nelson Committee had not had a single planning application for a new club or bar in the last fifteen years that he could remember. Mr Ilyas was encouraged to put any specific requests in writing so that they could be considered at either a meeting of this Committee or the appropriate area committee.

Mr Akram asked if the Council would make sure that no unlicensed taxi vehicles were on the road in the Christmas period. The Taxi Licensing Manager said that she was working closely with the

Police to try to ensure that this was the case. She encouraged Mr Akram to inform the Police immediately if he observed someone operating without a licence.

32. MINUTES

33. PENALTY POINT SCHEME

The Engineering and Special Projects Manager submitted a report asking members to consider an update to the penalty point procedure. The procedure had been amended to take account of members of staff leaving and new job titles given.

The Engineering and Special Projects Manager submitted a report which asked members to consider an application to renew a hackney carriage licence beyond the nine-year age limit.

RESOLVED

That Mr Hussain's application to renew his hackney carriage licence beyond the nine-year age limit when it expires in December 2012 not be agreed.

The Council's pre-licensing application conditions state that for this vehicle type a vehicle must be no older than seven years when first presented for licensing and can remain licensed until the vehicle is nine years of age.
