1. Following the relevant procurement process, tenders have been received and accepted in relation to the following project:-

## (a) Multi-Function Device (MFD) Replacement

In accordance with the Council's Contract Procedure Rules, tenders have been received for the replacement of the Council's fleet of Multi-Function Devices (MFDs). The Council's Management Team have agreed to award to Canon UK. Details of the tenders received for the whole life costs over the 5 year term are as follows:

The contract will run for 5 years and will be funded from within existing budgets.

The Executive agreed at its meeting held on 23<sup>rd</sup> October, 2014 to declare 108 Scotland Road, Nelson surplus to the Council's requirements to be marketed for sale in its current condition. Liberata Property Services advertised the property on 13<sup>th</sup> November, 2014 with a deadline of 9<sup>th</sup> January, 2015 for sealed bids.

An offer of £60,000 has been received with proof of funding provided by the offeror. The Executive is asked to approve acceptance of this offer.
