### **PURPOSE OF REPORT**

**Exemptions from Contract Procedure Rules (CPRs)**

2. CPR 5 include provision for exemption from the requirements to comply with CPRs in certain circumstances where it is considered justifiable, value for money is maintained and such action does not contravene EU and domestic legislation. Exemption from CPRs is, however, subject to the prior approval of the Corporate Director and Financial Services Manager provided that details of such exemptions granted are reported to the next possible meeting of the Executive.
3. Since the last meeting of the Executive, the following exemption to CPRs has been granted:-

*Domestic Abuse Services*

Earlier this year Lancashire County Council together with the 12 district housing authorities (including Pendle) were successful in securing funding to strengthen accommodation-based specialist domestic abuse service provision. Under the bid submitted, the Council will receive an amount of £55,490 in order to provide the following support services at the Women's Refuge:

- Refuge Support and Resettlement
- Support for Children and Young People
- Support for Complex Needs

The Council has limited in-house capacity to deliver the above services in full and proposes to commission the services from Pendle Action in the Community (PAC) via its subsidiary, Pendle Domestic Violence Initiative (PDVI). The Council has worked closely with PAC and PDVI for many years.

PDVI have the experience and expertise to provide the above services and this would build on existing service provision and minimise delays and additional costs arising from a formal procurement process. The Council will enter in a Service Level Agreement (SLA) which will specify the details of the services to be provided.

In view of the above, an exemption to the requirements of Contract Procedure Rules has been granted.
