Exemptions from Contract Procedure Rules (CPRs)

2. CPR 5 include provision for exemption from the requirements to comply with CPRs in certain circumstances where it is considered justifiable, value for money is maintained and such action

does not contravene EU and domestic legislation. Exemption from CPRs is, however, subject to the prior approval of the Corporate Director and Financial Services Manager provided that details of such exemptions granted are reported to the next possible meeting of the Executive.

3. Since the last meeting of the Executive, the following exemption to CPRs has been granted:-

Specialist cleaning at Pendle Wavelengths

Following a recent fire at Pendle Wavelengths, the agents appointed by the Insurer have sought quotes from two specialist companies for a high level clean of the building and contents.

The cost involved exceeds £50,000 which would normally require a formal tender process. However, CPR 5.2(b) allows for an exemption for reasons of time/urgency in circumstances unforeseen and not attributable to the Council.

The work is required before the reinstatement of the spa facility can commence therefore, in view of the above, an exemption to the requirements of Contract Procedure Rules has been granted. The costs will be reimbursed by the Council's insurers.
