

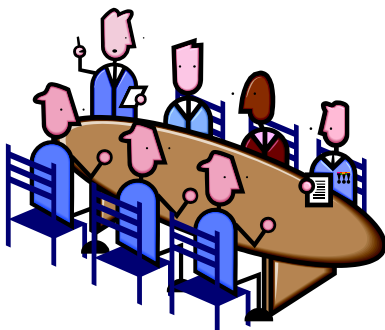

1. MINUTES

2. SCRUTINY REVIEWS

(a) Adult Social Care – Recommissioning of Homecare Services
