5. Results of a Spot Check

Enc. The Planning, Building Control & Licensing Services Manager reports, for information, that a joint spot check on licensed vehicles was carried out during the day of Friday 11th December 2015 at Rigg Street Motors, Nelson, with the Police and Vehicle Operator Services Agency (VOSA). Thirteen vehicles were tested in total with ten taken off the road for mechanical faults. A list of the vehicles tested and faults is attached. The vehicles which were suspended will revert to a four month licence and test.
