

## Transfer of Bus Passenger Shelters to Town and Parish Councils: A Position Statement at 14 March 2016

### Prologue

This covers all the passenger shelters in the Borough (other than those included in a contract with the advertising company Primesight, which is due to end in November 2016 and which will shortly be the subject of discussion with the company). Again, the target is to transfer these by 31 March 2016 with, in most cases, the town and parish councils agreeing initially to pay the Council the cost of maintenance (£106.38 per shelter per annum).

Barley Parish Council	1 x £106.38 = £106.38	The Parish Council expressed interest in taking over the bus turnaround as well as the bus shelter, which has been approved by the Executive  We have written to ask for clarification on whether they wish to maintain them themselves or pay us to do so
Barnoldswick Town Council	8 x £106.38 = £851.04	The Town Council is willing to take on ownership of the passenger shelters and initially pay Pendle the cost of maintenance
Barrowford Parish Council	7 x £106.38 = £744.60	The Parish Council has indicated that it is not willing to take over the bus stops unless they are repaired to a reasonable standard  A letter was sent out on 8 February 2016 with a schedule of works we plan to carry out. We are awaiting acceptance on this
Blacko Parish Council	2 x £106.38 = £212.76	The Parish Council is willing to take on ownership of the passenger shelters and will maintain them itself

Earby Town Council	5 x £106.38 = £531.90	The Town Council is willing to take over the responsibility for the five (please note) passenger shelters in Earby and that it will undertake the maintenance of them itself
