#### 11. Back Hargreaves Street Update

The Neighbourhood Services Manager reports that this back street has been investigated following concerns raised by the committee. It is an adopted highway maintainable by Lancashire County Council. The back street is on the current weed spraying route yet the spray team have been unable to gain access. A weed spray was carried out on 16/8/16 and an allowable time of 10 days is required for the spray to take effect, following this a the street will be cleaned by the cleansing team.

The highway construction appeared sound, yet will be more visible once the weeds are removed. There are a couple of missing setts which have been reported to Lancashire County Council.
