On the 9<sup>th</sup> August 2016 the Council received, from you, an application to vary the Designated Premises Supervisor at Europa, 94 Barkerhouse Road, Nelson BB9 9EU.

The Council's Licensing Enforcement Officer and colleagues from Lancashire County Council Trading Standards have met with the proposed Designated Premises Supervisor, Mr Arshad Javed, who has confirmed that he has no knowledge of the application being made in his name. In addition, he has also confirmed that the signature on the form is not his.

**In view of this, the sale of alcohol must cease with immediate effect and all alcohol must be removed from public view as, at the present time, there is no Designated Premises Supervisor at the premises.**

May I take this opportunity of reminding you that the mandatory condition below is attached to your premises licence in relation to the sale of alcohol;

***No supply of alcohol may be made under the Premises Licence at a time when there is no Designated Premises Supervisor in respect of the Premises Licence or at a time when the Designated Premises Supervisor does not hold a Personal Licence or his/her licence is suspended.***

Pendle Council, the Police and Trading Standards are extremely concerned that an application has been made in such a manner and would request that you contact the Licensing Office at Nelson Town Hall by telephoning 01282 661987 as soon as possible.
