

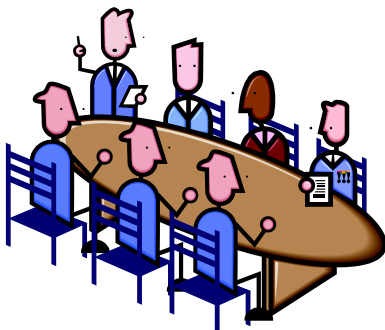


A MEETING OF THE
