#### 6. <u>Enforcement/Unauthorised Uses</u>

#### (a) Haddings Head, Higham

At the meeting on 12<sup>th</sup> December 2016 Members discussed complaints from residents about the situation at Haddings Head, Higham. The Neighbourhood Services Manager was asked to check that ambulances/paramedic vehicles could access the neighbouring properties; check that the fencing was secure enough to contain the dogs; and ask the Dog Warden to monitor the situation.

The Neighbourhood Services Manager reports that measurements of a standard dual staffed emergency ambulance are comparable to those of the vehicle now used by Environmental Services to collect refuse from the houses at Haddings Head. The Environmental Services vehicle has no difficulty accessing the site.

Overnight and otherwise when the landowner is not on site the dogs are kept in a secure stable building within the enclosure area so the adequacy of the fencing is not an issue. When the landowner is on site and the dogs are in the enclosure area the experience of officers is that the dogs make no attempt to leave their owner generally or when strangers approach the enclosure. There have been no reports of the dogs escaping from the enclosure area and the enclosure area is not included in the Community Protection Notice Warning issued in 2016. Officers will continue to monitor.

- 10. Local Plan Part 2

At the Executive on 17th November 2016, Members were informed of the progress on the preparation of the Pendle Local Plan Part 2. It was agreed that a cross-party Working Group be established to consider the strategic development of the plan. The first meeting of this group has now been held with the key issues and timetable for the preparation of the plan being discussed.

Also at the Executive, a draft report setting out the scope of the plan (i.e. the issues and policies it will cover – including the amount of housing to be developed in each settlement) and a methodology for the assessment of sites was presented, together with a report on the

Green Belt Assessment. It was agreed that these documents would form part of a public consultation. Since the Executive an additional document, the Sustainability Appraisal Scoping Report, has been drafted and will also form part of the consultation.

Members should note that the public consultation on these documents and an additional call for sites will begin in mid-February (dates to be confirmed) and will run for a period of six weeks. This consultation will provide the community and other interested parties with an opportunity to comment on, and shape the direction of, the Local Plan Part 2.
