The Committee was responsible for making decisions about any future proposals which would be developed over the next four years as part of the Healthier Lancashire and South Cumbria Programme. Members were also reminded of a STP scrutiny inquiry event being held by Lancashire County Council's Health Scrutiny Committee in March.

A copy of the East Lancashire Clinical Commissioning Group (CCG) newsletter, which provided information on the work of the CCG, its staff and its GP members was submitted for information.
