PURPOSE OF REPORT

REASON FOR RECOMMENDATION

To ensure that we retain focus on our priorities and deliver good value, accessible services.

ISSUE

Background

- 1. The purpose of the Strategic Plan is to articulate the actions that have been identified for the Borough for the next three years whilst also providing direction to the services that the Council delivers.
- 2. The Strategic Plan sets out our objectives for the future whilst individual service plans identify in more detail how we intend to achieve these objectives year-on-year. The service plans are used by managers as part of the day-to-day management of our services and provide the basis for which the delivery of services is performance managed.
