**17. MINUTES**

**20. ANNOUNCEMENTS FROM THE MAYOR AND LEADER OF THE COUNCIL**

On behalf of the Council the Leader expressed his sorrow and condolences to all those affected in the recent fire at Grenfell Tower in London. He advised that all council buildings and those of the Council's partners, such as Together Housing, had been inspected and were found to be sound. As a result the Council was reviewing its Emergency Plan.

Following recent security alerts all staff had been asked to wear their ID badges and the Leader urged all Councillors to do the same. Security around the Council buildings was considered to be slightly weak.

The Leader announced that a further 10 Syrian refugee families had arrived in Pendle with a formal welcome planned for 21<sup>st</sup> July. On behalf of the Council he congratulated the staff involved for all their hard work in ensuring the families were resettled, and in particular Wayne Forrest.

On behalf of the Council the Leader passed on his congratulations to Nelson and Colne College who, according to the latest data, had been placed as the top college in Lancashire.

**25. CAPITAL STRATEGY 2017/20**

**26. LOMESHAYE INDUSTRIAL ESTATE EXTENSION**

The Housing, Health and Economic Development Services Manager submitted a report on funding which had been secured, or was being sought, towards land acquisition, infrastructure and environmental enhancements to facilitate the extension to Lomeshaye Industrial Estate.

The report had been considered by the Executive on 22<sup>nd</sup> June, 2017 and Council were recommended as follows:

“That Council be recommended to approve a supplementary capital estimate of £1.9m to be funded from capital receipts to act as match funding.”

### **(b) Closure of Front Counters at Police Stations**

It was moved by Councillor D. M. Whipp, seconded by Councillor D. E. Lord –

Council notes with great concern:

- The closure to the public of police stations in Pendle.
- Increases in recorded crime figures in the Borough.
- Continuing difficulties with timely answering of calls to the police 101 number.
- The greatly reduced level of neighbourhood policing throughout Pendle, and
- The continuation of government cuts on police funding.

Council resolves that the Police and Crime Commissioner and the new Chief Constable be informed of the Council's concern and, in particular, opposition to police station closures; and that the Commissioner and Chief Constable be invited to attend a meeting to discuss these issues as a matter of urgency.

### **(c) Lancashire County Council**

It was moved by Councillor D. Clegg, seconded by Councillor A. R. Greaves –

Council notes the first decisions of the new County Council administration which priorities projects to the West of Lancashire rather than the East, e.g., highway repair funding from the Highway Incentive Fund and highway improvement funding from the National Productivity Investment Fund.

Council also notes that the County Council's new property strategy leaves question marks about the future of several Pendle facilities.
