FINANCIAL MATTERS

7. Capital Programme 2017/18

The Neighbourhood Services Manager reports that £1,850 remains unallocated from the Committee's 2017/18 Capital Programme. A full report will be submitted to the next meeting.

There is a request for a dog waste bin from a farmer who farms the land adjacent to a bridleway in Barley which is very popular with walkers who park up and walk up Pendle Hill. There is a dog bin at the roadside but nevertheless there has been a problem with dog poo bags being either tied to gates or thrown over walls into the farmer's fields. The request has come because of the concentration of these bags which are found about 100 metres from the road. It appears that walkers' dogs often do their business in this area and their owners do not walk back to the existing dog bin. The farmer therefore suggested siting a new bin in this area to help address the problem.

There is £156 left in the budget and the cost of the dog bin and erection would be £102.50.
