9. Residents-Only Parking Scheme - to Rear of Hope Street/ Manchester Road Nelson.

The Neighbourhood Services Manager reported receipt of a petition signed by 13 residents requesting residents only parking to the rear of Hope Street/ Manchester Road, Nelson.

10. <u>Condition of Back Street from No's 211 to 259 Manchester Road including the gable end</u> and No's 28 to 44 back Maurice Street, Nelson

At the last meeting it was agreed that costing be sought to improve the condition of the back streets.

The Neighbourhood Services Manager reports that the following costs are subject to full surveys and designs being carried out, once funding is confirmed.

- (a) Gable of 259 Manchester Road, Nelson Budget estimate £16,000
- (b) Back 211-259 Manchester Road, Nelson Budget estimate £23,100
- (c) Back 26-42 Victoria Street, Nelson Budget estimate £15,256

Lancashire County Council are responsible for Back 211-259 Manchester Road as it is an adopted highway and their permission will need to be requested and the specification may be altered by them affecting the estimate.

With regards the Gable of 259 Manchester Road, Nelson and Back 26-42 Victoria Road, Nelson these are un-adopted highways and will remain un-adopted and will be completed to a basic specification.
