Pendle Council has been commissioned by Lancashire County Council (LCC) to procure this on their behalf. The contract has been awarded to Colin Braithwaite Excavators Limited and will be funded by Lancashire County Council.

## (d) Merchant Card Services

The Council currently pays approximately £42,000 pa for card merchant services (i.e. processing fees for payments made by debit and credit cards). A contract for this service was placed out to tender in collaboration with Oldham Council and Burnley Borough Council. The procurement exercise has been led by officers from Oldham Council. Three tenders were received, two from the above and one from Barclaycard who's Oldham's Procurement Department deemed as non-compliant and was therefore excluded. As well as considering price, an evaluation of quality was also carried out by the three Councils and all concluded Lloyds Cardnet scored the highest in both categories. The contract is for an initial period of 3 years with the option to renew for a further 2 years on a 1 + 1 basis.

## Sale of Assets

2. Following the relevant process offers have been received in relation to the following site:-

# 32 Every Street, Brierfield

The Executive agreed at its meeting on 21<sup>st</sup> September 2017 to declare the property at 32 Every Street, Brierfield surplus to requirements and sold on the open market by informal tender. Liberata marketed the property for sale with a guide price of £12,000. Three offers ranging from £10,000 to £13,000 were received.

Best and final offers were invited by 10<sup>th</sup> November 2017, from everybody that had viewed the property. Seven offers were received ranging from £12,500 to £20,500. There is evidence from the highest bidder to show that he has sufficient funds available to acquire the property and carry out the refurbishment. He has also indicated in his offer that the refurbishment of the property and re-occupation will be completed in 6 to 8 months.

The Executive is asked to approve acceptance of the highest offer of £20,500.
