Consultation has occurred with various agencies concerned with homelessness across Burnley, Pendle and Rossendale. These agencies included registered providers, supported housing providers, local advice & support agencies, Probation / Community Rehabilitation Company (CRC), Job Centre+, health workers, drugs & alcohol mis-use services, Children's Social Care, Councillors and Pendle Borough Council departments.

All members of the Burnley, Pendle and Rossendale Homelessness Forum and service users of Safespace supported housing scheme were invited to provide comment/ feedback on the following three questions:

- What do you think are likely to be the biggest challenges over the next 5 years for homelessness services?
- What improvements / changes would agencies like to see in homelessness service provision?
- Any further ideas which you would like to put forward

A wide variety of responses were made which have been documented in the Pendle Homelessness Review 2017 and responded to. Some of the responses will result in actions within the Homelessness Strategy.

The Pendle Homelessness Review 2017 was also circulated to the Burnley, Pendle and Rossendale Homelessness Forum to seek feedback in terms of the content and the recommendations.

There were 24 responses to the aforementioned consultation. A number of challenges were identified for homelessness services over the coming years. These included:

- Introduction of the Homelessness Reduction Act 2017
- Potential changes to supported housing scheme eligibility for 22-24 year olds which may mean such schemes will no longer be available.
- Potential lack of funding
- Changes to welfare benefits / universal credit introduction
- Lack of emergency accommodation in Pendle

A number of improvements were also suggested. These included a need for:

- More supported housing for young people in Barnoldswick / Earby
- Better communication between agencies

Statistics often show that young people are disproportionately affected by homelessness and therefore a number of actions are aimed at preventing homelessness within this age group. Further, it is also recognised that those who are vulnerable would likely suffer greater hardship than those less vulnerable when homeless and therefore some actions are also aimed at this group. Whilst vulnerability itself is not a protected characteristic, young people aged 16-17 and elderly people are perhaps more likely to be more vulnerable due to age than others. However, whilst some groups will benefit, it will not be at the expense of any other group.
