- 10. Environmental Blight

There are no existing environmental blight sites and no new sites have been put forward.

The definition of an environmental blight site is:

- Untidy/derelict piece of Council land requiring tidying up and maintaining.
- Untidy/derelict piece of unregistered land requiring tidying up and maintaining.
- Untidy/derelict piece of Council-owned or unregistered land which needs regenerating (eg a former garage colony converted to a landscaped parking area). New sites should be reported to Tricia Wilson or Peter Atkinson including a contact name and contact details with a brief description of the site and the problem.

11. Roll-out of Superfast Broadband in AONB, Barley

As discussed at the last meeting, Openreach are carrying out a roll-out of superfast broadband mainly in the AONB in Barley. Some poles have already been erected but at the last meeting Members made it clear that they wanted to see underground cables being used rather than overhead telegraph poles. Full details are still awaited. A verbal report will be given at the meeting.
