48. STREET TRADING CONSENT APPLICATION

The Planning Building Control and Licensing Services Manager submitted a report regarding an application for street trading consent. It was reported that the application was to sell fresh fruit and vegetables on the locations outlined on page 3 of Appendix 1 of the report. The applicant had requested to trade from 11.00am to 7.00pm Monday to Friday. It was confirmed that the applicant was over the age of 17 and a basic disclosure form accompanied the application and was clear

from convictions. The vehicle insurance had been checked and had the correct business insurance. The Licensing Enforcement Manager also reported that the name of the business was not the same or similar to that of an existing static retail business or another street trader.
