# DECLARATION OF INTERESTS

## PUBLIC QUESTION TIME

Mrs Ridehalgh from Gisburn Road, Barrowford had asked a question on 7<sup>th</sup> September about whether planning permission was required to display a Higherford sign and to object to the proposal from the Higherford Residents' Action Group to display such a sign at the corner of Bankhouse Mews. At this meeting she referred to a meeting on the following Monday evening to discuss the placement of the sign and asked for the Committee's support in siting it close to where it had originally stood for many years.

The Chairman said that a sign would need planning permission if it wasn't on private land. She thought that the most suitable place would be opposite Bramble Cottage or on the Malt Kiln and Mrs Ridehalgh agreed. Some members of the Committee said that they would be at the Monday meeting and would support this proposal.

Mrs Peacock from Wilton Street was concerned about the volume of traffic on her street and the speed at which vehicles travelled, particularly at drop off/pick-up times for the nursery during the week and for football and cricket matches, mainly at weekends. There were also a lot of people who used the car park to then walk their dogs in the park. Some visitors were parking on Wilton Street, rather than the car park, which was residents-only parking but nothing was being done to

enforce this. She asked if the Committee could do something to slow the traffic down and if the parking enforcement officer could visit from time to time.

County Councillor Wakeford said that he would raise the matter with the relevant Cabinet Member at County Council and see if there was anything that could be done about enforcing the residents-only parking scheme and erecting a 20mph sign. PC Dibb said that the length of road prohibited the use of a speed gun but people could be charged for driving without due care and attention.
