Minutes of the meetings are currently submitted to the Health and Social Care Scrutiny Panel for information.</p> <p>However, as a result of changes to Pendle Council's governance arrangements the Health and Social Care Scrutiny Panel will no longer operate following the Annual Council meeting in May 2018.</p> <p>It is proposed that a Standing Panel will continue to look at health issues.</p> <p>Alternatively, it has been suggested that the existing Panel, the Clinical Commissioning Group (CCG) Steering Group and the Pendle Health and Wellbeing Partnership Board amalgamate.</p> <p>Any significant changes relating to the delivery of mental health services will therefore be reported to the appropriate group once established.</p>
