Annex 1 - Mandatory Conditions

A1.

When a film is exhibited, admission of children to that part of the premises must be restricted in accordance with any recommendation made by the appropriate film classification body in relation to that film.

A2.

Where no recommendation exists from the appropriate film classification body or the Council notifies the premises under section 20(3)(b) Licensing Act 2003, the admission of children will be restricted in accordance with any recommendation made by the Council.

Annex 2 - Conditions consistent with the Operating Schedule

B1. Prevention of Crime and Disorder

B1.1

The Police, Fire and Rescue Authority and the Licensing Section of Pendle Borough Council will be informed of any events taking place under the authority of the Premises Licence.

B1.2

The name and contact details of the responsible person appointed by Barnoldswick Town Council will be notified in writing to the Police, Fire and Rescue Authority and the Licensing Section of Pendle Borough Council. Any change in the details of that person will be notified immediately to each of the three parties.

B2. Public Safety

B2.1

All events taking place under the authority of the Premises Licence will be logged in a register and authorised by a member of Barnoldswick Town Council appointed for that purpose.

B2.2

The register of events will be made available to the Police or a Licensing Officer of Pendle Borough Council on request.

B2.3

A risk assessment will be undertaken in respect of each event taking place at Barnoldswick Town Square. The appointed member of Barnoldswick Town Council will ensure that all appropriate documentation has been obtained and any risk assessments undertaken prior to an event taking place in the Square.

B3. Prevention of Public Nuisance

B3.1

An assessment of potential litter nuisance will be made in respect of each event held in Barnoldswick Town Square and, where required, arrangements will be made for the responsible collection and disposal of any litter from the site.

B3.2

There will be an assessment of potential noise prior to an event taking place and Pendle Borough Council Environmental Health Section will be contacted for advice if necessary.
