If the item is a planning application then you must make your request in writing or by telephone by 12 noon on the day of the meeting.



#### 17. Trees at Thomas Street Car Park, Colne

This item was deferred at the last meeting and is submitted again for further consideration.

The Planning, Building Control and Licensing Services Manager reports that all six trees on the Thomas Street car park are relatively small and immature. They are enclosed by hard surfacing with little open ground for them to grow and their environment is a poor one for the trees to grow in. Although the trees are generally healthy, a couple show signs of damage. The root systems of most of the trees are also impacting on the surface of the car park, kerbs and surrounding stone flags. This could result in the removal of the trees in the future.

As the trees are not large and only contribute limited biodiversity in the area it is not considered that the trees are protected through a Tree Preservation Order.
