

MINUTES of AGM

- 2. MINUTES of last AGM on $18^{\rm th}$ April 2017 were accepted as a true record, proposed, Paul, seconded, Helen

3. MATTERS ARISING:

- Review of LNR Management Plan delayed due to Lee's work commitments –
 Paul to draw up a list of items for Plan and submit them to Lee for approval.
- Woodland between Canal and Barrowford Road owned by Begley's Farm and under their Stewardship in need of management
- The Dog Pound by the canal is in a neglected state with fencing blocking a permissive footpath (Colne Greenway) between the canal and river – contact Tom Partridge, Footpaths Officer.

4. REPORTS: Chair & Volunteer Reserve Manager:

- Less drug items but more litter on LNR and some fly tipping along the road.
- Vandalism has increased (damage to railings and boarding around Pond, stone seat in Woodland) and another attempted break in to the green metal cabin
- Regular Working Parties on Saturdays hampered by the weather
- Paul and Team have erected 20 bird boxes (bat boxes still to be installed)
- 400+ saplings planted in LNR and hedging in the Woodland
- Pond has been cleaned and cleared; still items in the river to be retrieved
- It was noted that there will be less support from the Council due to cut backs and reorganisation of Council Departments
