Hearing 3 rd March 2017. Owners pleaded guilty. They were given a conditional discharge and ordered to pay £200 costs and £40 victims surcharge. Work being undertaken. Progress being monitored. |

Land to the north east of Cowfield Farm, Burnley Road, Trawden, Colne | 2806 | Delegated 25/8/17 | 31/8/17 and 1/9/2017 | 12/10/17 | 07/12/17 | Enforcement Notice under Section 172 of the Town and County Planning Act 1990. The Notice required the owner to demolish the building erected on the Land and following demolition to remove all materials and debris arising from the demolition and to remove all related footings, foundations and other underground structures from the Land. An appeal has been received. Hearing date set for September. |
| 4. Land to the north east of Cowfield Farm, Burnley Road, Trawden, Colne | 2807 | Delegated 25/8/17 | 31/8/17 and 1/9/17 | 4/9/17 | 4/9/17 | Stop Notice under Section 183 of the Town and Country Planning Act 1990. The Notice required the owner to cease all activity relating to the unauthorised erection of a single storey dwelling on the Land. |
| 5. The Crown Hotel, 94 Albert Road, Colne | 2941 | Delegated 7/3/18 | 21/3/18 | 2/5/18 | 30/5/18 and 2/11/18 | Enforcement Notice under Section 172 of the Town and Country Planning Act 1990. The Notice required the owner to submit to the LPA details of replacement timber window frames , remove the two UPVC window frames to the first floor south elevation and replace the window frames in accordance with the approved details. |

The Notice required the owner to demolish the external wooden fire escape, balustrades and fencing on top of the outrigger and demolish the first floor block built wall. The owner is also required to make good any damage following demolition and remove all materials arising from the demolition. |
