- 8. Problem Buildings
- **Enc.** The Planning, Building Control and Licensing Services Manager submits the attached report about problem buildings in the Barrowford and Western Parishes area.
- 9. Environmental Blight

There are no existing Environmental Blight sites and no new sites have been put forward.

The definition of an environmental blight site is:

- Untidy/derelict piece of Council land requiring tidying up and maintaining.
- Untidy/derelict piece of unregistered land requiring tidying up and maintaining.
- Untidy/derelict piece of Council-owned or unregistered land which needs regenerating (eg a former garage colony converted to a landscaped parking area).

New sites should be reported to Tricia Wilson or Peter Atkinson including a contact name and contact details with a brief description of the site and the problem.

#### 10. Footpath improvement scheme – Barrowford to Barley

At the meeting of 10th May the Neighbourhood Services Manager was asked to provide advice to Roughlee Booth and Barley Parish Councils on possible help and advice on accessing funding for a footpath scheme to improve a section of prominent footpath running from Barrowford to Barley, which was becoming urgent, and not something the Committee could wholly fund.

A meeting has since taken place attended by the Countryside Access Officer (CAO) and the Senior Localities and Policy Officer (SLPO) for Neighbourhood Services, and representatives of the parish councils. The CAO has agreed £5,000 from the countryside access revenue budget towards the project and some of this funding has already been committed to an ecological study which is taking place over the summer (this is one of the requirements for Land Drainage Consent which needs to be obtained before work on the project can commence).

The Council's engineering section is currently preparing design drawings and a method statement (which are also required in connection with the application for land drainage consent). The engineering section is also providing budget estimates. The SLPO has prepared a draft expression of interest for funding towards the project from the Lancashire Environment Fund (LEF). If funding towards the project is approved by this Committee then this, together with the other funds which have already been committed, will demonstrate the necessary % of local funding which LEF requires is obtained before awarding a grant.

The SLPO is also in the process of contacting Burnley FC in the Community which may be willing to contribute funds, with their facilities at Whitehough being so near.
