As noted above, I am the tenant that currently resides in the property next door to the lounge in Barrowford. I have strong objections to the application for an extended license which has been outlined in the public notice: for numerous reasons.

For your information we are a hard-working family with two small children, I work various shift patterns, as does my husband. When we made the decision to move here it wasn't without thought and we were under the impression that this was a nice bar/restaurant that would be suited to a particular clientele, however this is not the case.

I have had numerous dealings with environmental health in relation to nuisance directly caused from the lounge. Historic and also ongoing complaints. The music that was being played particularly in December 2017/ January/ February 2018 was dance/house music which was so loud we couldn't hear the television and kept the children awake, but this also, attracted a particular customer which caused a problem when people started to leave the premises following hours of drinking. Arguments often erupted directly outside the house, people became violent, taxis were directly outside the house beeping their horns – just some of the examples.

Currently the music that is being played is much more relaxed and at an acceptable noise level, however, all of the other problems raised above still stand. There are people sat directly outside the house drinking, I have removed drinking glasses and cleaned peoples vomit off our wall! They are using offensive language (which our children hear). Taxis are pulling up and people are shouting and singing. When there is live music on, it is unbearable in the house — it sounds as if we are sat in the same room and if this was to be allowed to go on until later than it currently does I feel it would have a negative impact on my daily living and that of my family.

I feel that this already negatively impacts on my children from the issues raised above, but also, to the rear of the property there is broken glass right outside my door, the bins are near on always overflowing, as I write this there are at least 10 bin bags leaking on the floor outside. I have already had an ant infestation, and surely this is the cause, if not, adding to the problem. I am unable to open the back windows for the smell and flies. I have concerns in relation to what else this may attract as we move into summer. I have discussed this numerous times with the manager with no success.

There are known drug dealings going on which I have registration numbers for, directly outside the house which I believe are customers of the lounge. There are also 'lock ins' happening, which, for the last two consecutive Fridays woke us all up at 02.45 in the morning when they left the premises and made a lot of noise in the process.

I understand that some of my concerns cannot be addressed by environmental health or licensing, as there is a lack of evidence and also the disturbances are often caused by people leaving the premises which obviously the lounge cannot control; however; I have real concerns that if people are allowed to continue drinking alcohol until the later time of 2am and the license is accepted to play live music until a later time that this would almost certainly make it unbearable for us as a family, and for the other residents that live nearby. There are a number of outstanding issues that have been raised and to grant a later license would only exacerbate the problem.

I'd like to take this opportunity to remind the individuals that are making such a decision that this is not a night club, and it's situated in a small quiet village. I urge them to think how they would feel if they had this to live with every day.
