## A COUNCIL TAX 2017/18 - CALCULATIONS

It is recommended that the Band D Council Tax for the Borough of Pendle services be set at £250.16 for the financial year 2017/18.

## B COUNCIL TAX DECLARATION

The Council is recommended to resolve as follows:-

- 1 It be noted that, at its meeting on the 8th December 2016, the Executive calculated the Council Tax Base 2017/18:-
- a) for the whole Council area as 23,348.30; (Item T in the formula in Section 31B of the Local Government Finance Act 1992, as amended (the "Act")); and
- b) for dwellings in those parts of its area to which a Parish precept relates as follows:

3 That the following amounts be calculated for the year 2017/18 in accordance with Sections 31 to 36 of the Local Government Finance Act 1992:-

a) £52,217,142 Expd (including local precepts)	being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (2) of the Act taking into account all precepts issued to it by Parish Councils; <b>subject to any final amendments agreed at the Council</b> <b>meeting on 23rd February 2017.</b>
b) £44,897,130 Income (including Govt Grants)	being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act <b>subject to any final amendments agreed at the</b> <b>Council meeting on 23rd February 2017.</b>
c) £7,320,012	being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax Requirement for the year. (Item R in the formula in Section 31B of the Act).
d) £313.51	being the amount at 3(c) above (Item R), all divided by Item T (1(a) above), calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).
e) £1,479,202	being the aggregate amount of all special items (Parish precepts) referred to in Section 34 (1) of the Act.
f) £250.16	being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by Item T (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council tax for the year for dwellings in those parts of its area to which no Parish precept relates.

g) the following amounts calculated by the Council as the basic amounts of its Council Tax for the year for dwellings in those parts of its area to which one or more special items relate:-
