POLICE ISSUES

PC Dibb presented the crime statistics for Barrowford and Western Parishes for June 2018 compared to the same period in 2017 and answered related questions. Crimes were broken down as follows –

He provided an overview of police activity over the past month and gave updates on previously reported crimes. Members raised issues of concern at Pendle Forest Sports Club which PC Dibb noted and said he would take appropriate action.

He also reported on upcoming cuts to neighbourhood police officers. He advised that the number of Community Beat Managers in Pendle would be halved with those remaining having a more dedicated community role. The other officers would be redeployed into key areas such as safeguarding, organised crime and burglary within Pendle.

29. PLANNING APPLICATIONS

(a) Planning applications to be determined

The Planning, Building Control and Licensing Services Manager submitted a report on the following planning applications for determination -

That planning permission be **refused** for the following reason –

1. The design of the proposed dwellings are not in keeping with the area and would result in unacceptable harm to the character and scenic beauty of this part of the Forest of Bowland

Area of Outstanding Natural Beauty contrary to policies ENV1, ENV2 and LIV5 of the Pendle Local Plan Part 1: Core Strategy and paragraphs 64 and 115 of the National Planning Policy Framework.

18/0268/OUT Outline: Major: Residential Development of land 0.92 ha. For 20 dwelling houses with access off Gisburn Road (Access and Layout); Full: Demolition of 372 Gisburn Road (Re-Submission) at Land to east of 372 Gisburn road, Blacko for Mr Calvert and Mr Wilds

RESOLVED

That planning permission be refused for the following reasons -

- The proposal would fail to provide a safe and suitable access to the site and therefore would not be in accordance with Policy ENV4 of the Pendle Local Plan Part 1: Core Strategy 2011 – 2030 and the National Planning Policy Framework paragraph 32.
- 2. The proposal has failed to provide adequate provision for potential flood risk and therefore would not be in accordance with Policy ENV7 of the Pendle Local Plan Part 1: Core Strategy 2011-2030.
- 3. The proposed development would result in a cramped layout due to the limited depth of rear gardens, particularly to the eastern side of the proposed estate road and insufficient off-street car parking provision for the residents. The application therefore would not be in accordance with policies ENV2 and LIV5 of the Pendle Local Plan Part 1: Core Strategy 2011 -2030 and saved policy 31 of the Replacement Pendle Local Plan.

(b) Planning Appeals

The Planning, Building Control and Licensing Services Manager reported that the following appeal had been dismissed -

REASON

34. FOOTPATH IMPROVEMENT SCHEME – BARROWFORD TO BARLEY

At the meeting of 10th May the Neighbourhood Services Manager was asked to provide advice to Roughlee Booth and Barley Parish Councils on possible help and advice on accessing funding for a footpath scheme to improve a section of prominent footpath running from Barrowford to Barley, which was becoming urgent, and not something the Committee could wholly fund. A meeting had since been held with officers and representatives of the parish councils.

The Council had allocated from the £5,000 from the countryside access budget towards the project. The Lancashire Environment Fund (LEF) had been approached for funding. It was hoped that Burnley FC in the Community might be willing to contribute funds, with their facilities at Whitehough being so near. The Pendle Hill Landscape Partnership Fund was also mentioned as a possible source of income.
