HIGHWAYS ISSUES

8. <u>Highway Safety Issue, Skipton Road, Barnoldswick</u>

At the 5th December, 2017 meeting, reference was made to an accident on Skipton Road, where a taxi had come over the bridge too fast, hitting a vehicle, which in turn had hit another vehicle. The Traffic Liaison Meeting was asked if there were any road safety measures which could be put in place to improve road safety along this stretch of Skipton Road.

Following various discussions it was suggested that a SpID be erected on the column by the bridge (Brindley Mews side) on Skipton Road. However, CC advises that this is a concrete column which isn't suitable and they are unable to change the existing column at this time as it is not currently due for replacement.
